**ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

Article 1 - Name and Address

Article 5 - Initial Officers & Directors

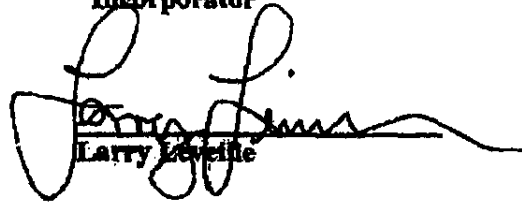
Larry Levelle shall initially serve as the sole Director and as the President, Secretary, and Treasurer.

Article 6 - Incorporator

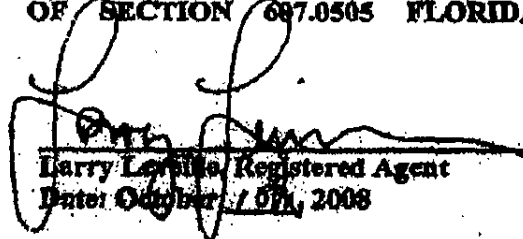
