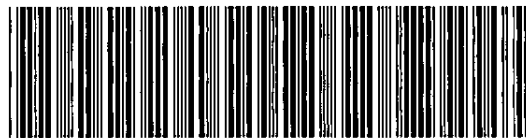

NAME

The name of this corporation is SRA ASSET ACQUISITION CORP.

ARTICLE II.

PRINCIPAL OFFICE

ARTICLE III.

DURATION; EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of the date of filing of these Articles.
