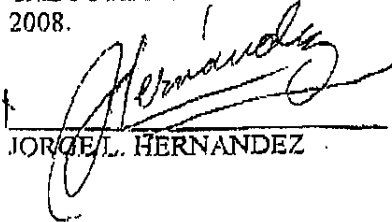
AMENDMENT

ARTICLE XII

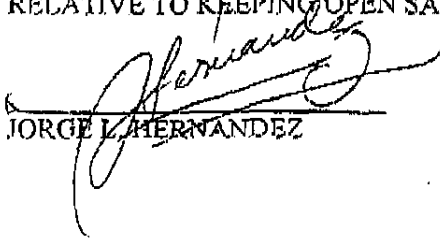
