OF

RSBARBONE, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

Article I Name

Section 1.1. Name. The name of this corporation shall be RSBARBONE, INC.

Article II Principal Office and Mailing Address

<u>Section 2.1.</u> <u>Principal Office and Mailing Address.</u> The principal place of business and mailing address of this corporation shall be 33 CORONA ROAD, PONTE VEDRA BEACH, FLORIDA 32082.

Article III Capital Stock

- <u>Section 3.1</u>. <u>Capital Stock</u>. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 7,500 shares of common stock having a par value of \$0.10 per share.
- <u>Section 3.2.</u> Restriction on Transfer of Stock. The shareholders may, by bylaw provision, by shareholders' agreement recorded in the minute book or by endorsement on each stock certificate, impose such restrictions on the sale, transfer, or encumbrance of the stock of this corporation as they may see fit.
