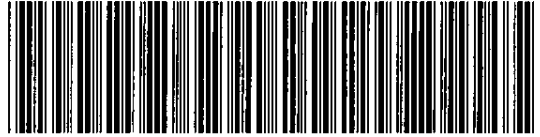

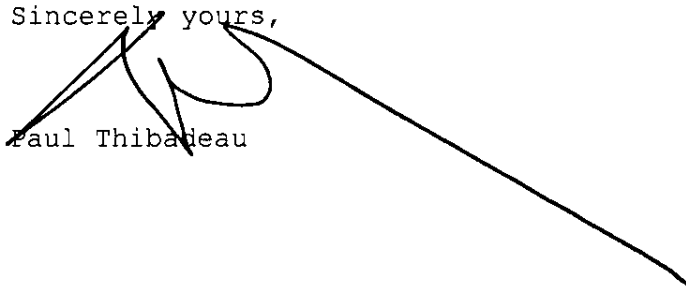

ARTICLES OF INCORPORATION OF HARBOUR EXECUTIVE SUITES, INC.
TALLAHASSEE, FLORIDA

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I-NAME

The name of the Corporation shall be HARBOUR EXECUTIVE SUITES, INC.
(the "Corporation").

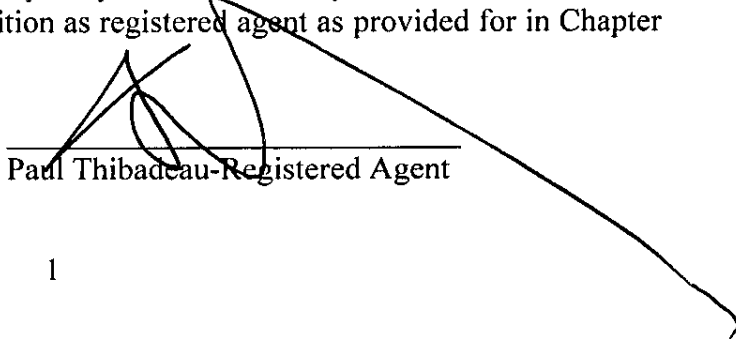
ARTICLE IV-SHARES

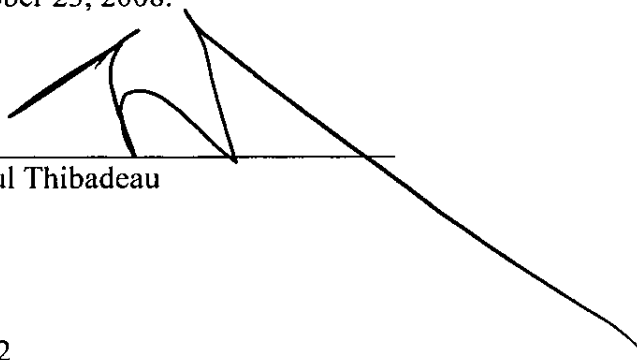
