The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

# ARTICLE 1.0 NAME AND ADDRESS

The name of the Corporation is Jack P. Campbell, D.M.D., P.A. The location of the principal place of business is 1700 Wells Road, Suite 19, Orange Park, FL 32073 and the mailing address is the same.

# **ARTICLE 2.0 DURATION**

The duration of the Corporation is perpetual.
