**ARTICLES OF INCORPORATION
NORTH CENTRAL FLORIDA DEVELOPERS CORPORATION**

The undersigned Incorporator of North Central Florida Developers Corporation hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be North Central Florida Developers Corporation ("Corporation"). Its initial place of business and mailing address shall be One Northeast First Avenue, Ocala, Florida 34470.

ARTICLE II

The general nature of the business to be transacted by the Corporation shall be that of any business permitted under the laws of the United States of America and the State of Florida.

ARTICLE III

The total number of shares authorized to be issued by the Corporation shall be 10,000,000. Of such shares, 9,000,000 shall be common stock, \$0.01 par value and 1,000,000 shall be undesignated preferred stock.

ARTICLE IV

The term for which said Corporation shall exist shall be perpetual.


ARTICLE V

The number of directors shall not be fewer than one. A majority of the full board of directors or of the shareholders may, at any time during the year following the annual meeting of shareholders, increase the number of directors by not more than two directors, and appoint persons to fill resulting vacancies. The initial size of the Board of Directors shall be three and its members shall be: Jon Kurtz, Matthew Ivers and Lorelee W. Miller.

ARTICLE VI

The officers of the Corporation shall be a President and a Secretary/Treasurer, and any other offices as may be established by the Board of Directors from time to time. The initial President shall be Jon M. Kurtz and the initial Secretary/Treasurer shall be Matthew Ivers.

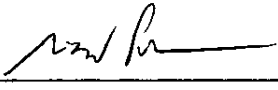
