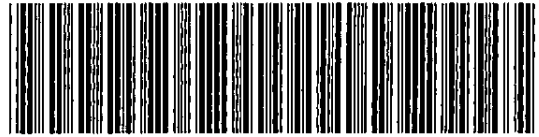

The undersigned, for the purpose of forming a corporation under the Florida Professional Service Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME


