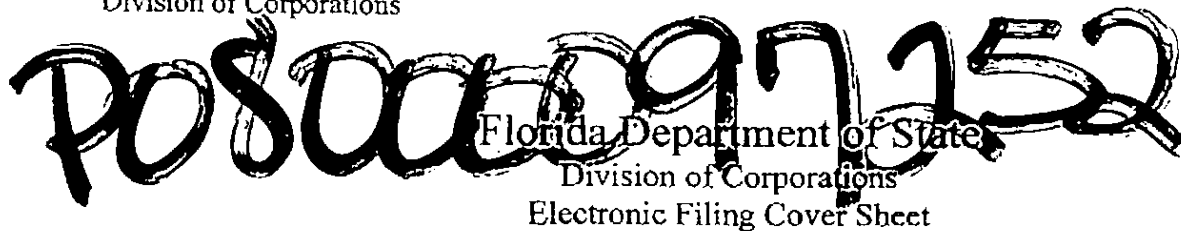

**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION OF  
CORRELOG, INC.**

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Business Corporation Act (the "FBCA"), CorreLog, Inc., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

**ARTICLE I**

**Name**

The name of the Corporation is CorreLog, Inc.

**ARTICLE II**

**Amendment to the Articles of Incorporation**

Article I of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and replaced to read as follows:

**"ARTICLE I.**

**Name**

The name of the corporation (hereinafter referred to as the "Corporation") is HPG Associates, Inc."

**ARTICLE III**

**Date of Adoption**

This amendment to the Articles of Incorporation of the Corporation (the "Amendment") was adopted on the 10th day of October, 2018.

**ARTICLE IV**

**Manner of Adoption**

Pursuant to the provisions of Section 607.0821 of the FBCA, effective October 10, 2018, the board of directors of the Corporation duly approved and adopted the Amendment through an action taken by the unanimous written consent and recommended that the shareholders of the Corporation approve the Amendment. Pursuant to the provisions of Section 607.0704 of the FBCA, effective October 10, 2018, the Amendment was duly approved and adopted in an action taken by unanimous written consent of the shareholders of the Corporation.

Accordingly, the Amendment has been authorized by all appropriate action under the FBCA.
