OF

The undersigned acting as subscriber(s) of a corporation under the Florida Corporation Law, adopt the following Articles of Incorporation fur such Corporation.

Article I

The name of the Corporation is: DOWN SOUTH TRUCK & CAR SERVICES, INC

Article II

The purpose for which the Corporation is organized is to engage in any activity or business permitted under the Law of the United States and the State of Florids.

Article III

The maximum number of shares which the corporation is authorized to issue and have outstanding at any one time is 500 shores of Common Stock, and which common stock shall be of \$1.00 par value; all stock is to be issued as fully paid and exempt from assessment
