

## ARTICLES OF INCORPORATION OF FUN CITY SWEEPSTAKES, INC

#### ARTICLE I

Name. The name of this corporation is FUN CITY SWEEPSTAKES, INC.

#### ARTICLE II

Duration. The corporation shall be perpetual.

#### ARTICLE III
