ARTICLE I
Name

The name of the corporation is SD (MPC 26A, 26B & 26C) Corp.

ARTICLE II
Duration

This corporation shall have a perpetual existence, unless dissolved according to law, commencing on the 3rd day of November, 2008.

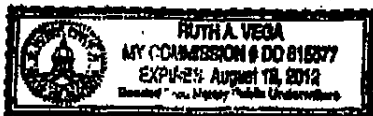




