ARTICLE IX


GENERAL PROVISION:

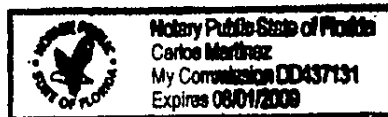
