



### FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

THIS CAUSE came to be heard upon the Petition for Dissolution of Marriage filed by Wife. After reviewing the Court file and being otherwise advised, the Court FINDS as follows:

- 1. The Court has jurisdiction of the parties and the subject matter herein.
- 2. The Petitioner has been a resident of the State of Florida for at least six (6) months prior to the filing of the Petition for Dissolution of Marriage.
- 3. Irreconcilable differences exist and have caused the irretrievable breakdown of the marriage, and all efforts and hope of reconciliation would be impracticable and not in the best interests of the parties.
- 4. The parties wish to settle between themselves their respective rights, duties, and obligations regarding property and liabilities, and so have entered into a written Marital Settlement Agreement. This Agreement was entered into voluntarily by each party and has been filed of record in this cause.

## IT IS, therefore, ORDERED and ADJUDGED as follows:

- A. The parties are awarded Judgment for Dissolution of Marriage, and the bonds of matrimony heretofore existing between Francisco Sanchez (hereinafter referred to as "Husband") and Alana Hester Sanchez (hereinafter referred to as "Wife") are hereby dissolved.
- B. The Marital Settlement Agreement of the parties, incorporated herein by reference for all purposes, is approved and expressly made a part of this Final Judgment for Dissolution of Marriage, and all of the terms and provisions of said Agreement are RATTFIED, CONFIRMED, and ADOPTED as Orders of this Court to the same extent and with the same force and effect as if its terms and provisions were set forth verbatim in this Final Judgment, and the parties are ORDERED to comply with the terms and provisions of said Agreement.

- C. The Wife's former name of Alana Rence Hester is hereby RESTORED.
- D. Each party shall (a) provide to the other party any necessary information or to execute and/or deliver any instrument or document necessary to transfer title or interest in property consistent with this Final Judgment or the Marital Settlement Agreement, and (b) timely perform such other acts that are reasonably necessary or that may be reasonably requested by the other party to effectuate the provisions of this Final Judgment or the Marital Settlement Agreement.
- E. Any right, claim, demand or interest of the parties in and to the property of the other, whether real, personal or mixed, of whatever kind and nature and wherever situated, including but not limited to homestead, succession and inheritance arising out of the marital relationship existing between the parties hereto, except as expressly set forth or arising out of said Marital Settlement Agreement, is forever barred and terminated.
- F. The Court expressly retains jurisdiction of this cause for the purpose of enforcing, construing, interpreting, or modifying the terms of this Final Judgment and the terms of the Marital Settlement Agreement entered into by the parties herein.
