The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is Liner Holdings, Inc. and its principal office and mailing address is 11811 31st Court North, St. Petersburg, FL 33716.

Commencement of Corporate Existence

The corporation shall come into existence on the date of filing with the Florida Secretary of State.

General Nature of Business
