A Florida Corporation

The undersigned incorporator to these Articles of Incorporation hereby associates to form a corporation (the "Corporation") under Chapter 607 of the Florida Statutes.

1. Name

The name of the Corporation is Eck & Associates, Inc. The Corporation's principal office (and mailing address) is located at 4183 Bay Beach Lane, #313, Fort Myers Beach, FL 33931 in Lee County, Florida.
