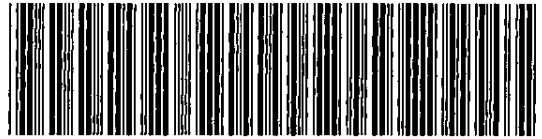

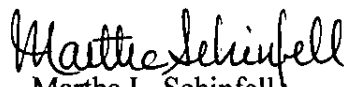
**ARTICLE XII

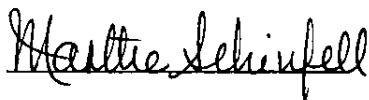

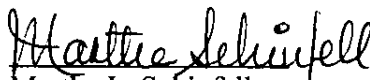
