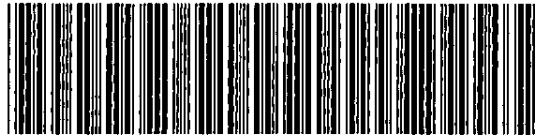



ARTICLE I. NAME

The name of this corporation is
D & D UTILITIES, INC.

ARTICLE II. DURATION

This corporation shall commence January 1, 2009, and
shall have perpetual existence.




