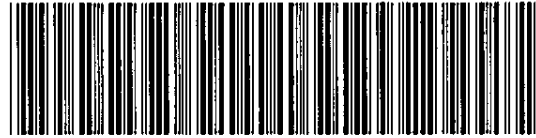



The corporation shall exist perpetually, commencing as of November 11, 2008.


