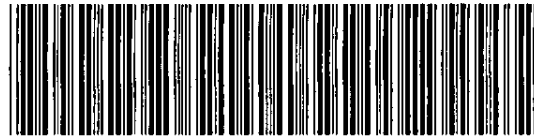

**ARTICLES OF INCORPORATION
OF

ARTICLE I

The name of the corporation is TOJO FINANCIAL XII, INC.

The corporation shall exist perpetually, commencing as of November 11, 2008.


