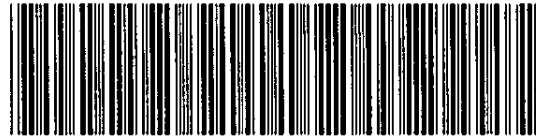

The name of the corporation is TOJO FINANCIAL X, INC.

ARTICLE II Effective Date *Nov. 11, 2008*

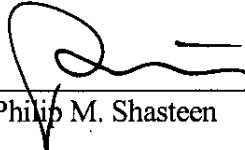
ARTICLE VI
