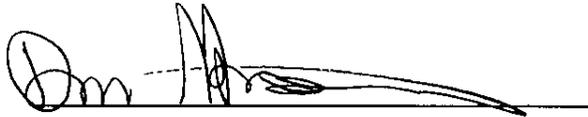
Article I – Name of the corporation shall be, and is hereby amended to read, as follows:
