ARTICLES OF INCORPORATION OF NATIONAL RADIOLOGY SERVICES, INC.

The under signed, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopt the following Articles of Incorporation.

ARTICLE I: NAME

The name of this corporation shall be **National Radiology Services, Inc.**

ARTICLE II: DURATION OF BUSINESS

The term of existence shall begin November 12, 2008, and shall be perpetual.

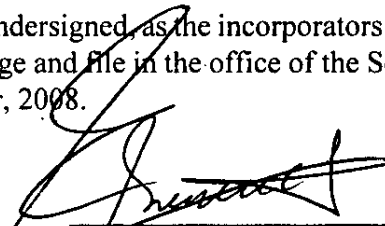
ARTICLE X: SEAL

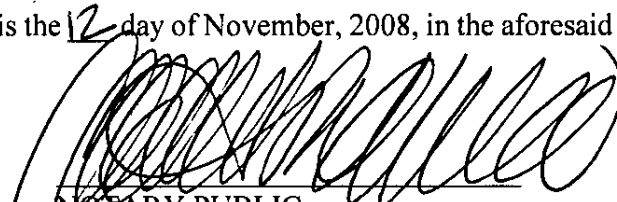

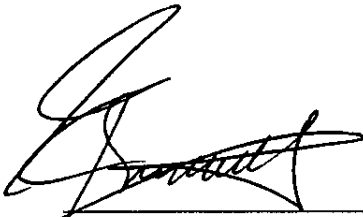
