ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

Article I

Name

Section 1.1 **Name.** The name of this corporation shall be RCBAP FLOOD REBATE PROGRAM, INC.

Article II

Principal Office and Mailing Address
