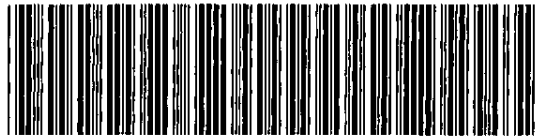


Upon realizing my mistake, I converted Marquesas Financial Services, Inc. back to Crossmark Partners, LLC on November 12, 2008.
