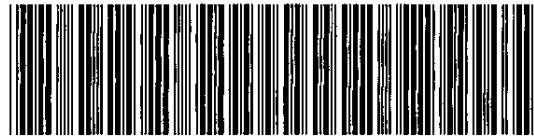



OF

ARTICLE I. NAME

The name of this corporation is

shall have perpetual existence.




