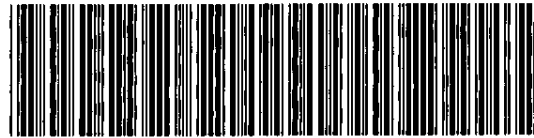

**ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under Florida General Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE I

The name of this corporation shall be **TREASURE COAST COMPUTER SERVICES & CONSULTING, INC.**, hereinafter referred to as the "corporation."

This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida. The purpose for which this corporation organized is computer consulting.

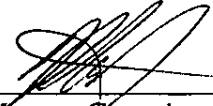

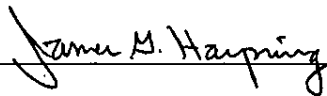

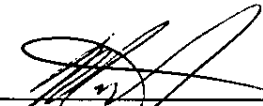
