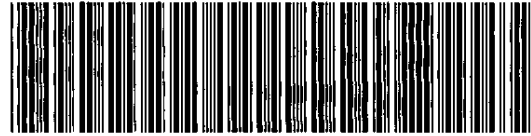

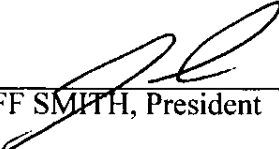
ARTICLE I, be and it hereby is amended to read as follows:
