ARTICLE I - NAME

The name of the Corporation is Atrium Nursing Care, Corp., (hereinafter, "Corporation").

ARTICLE XIV - AMENDMENT

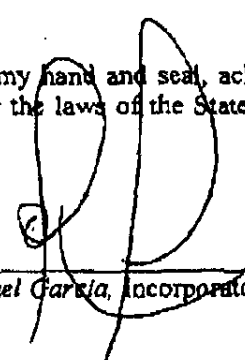
