

ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

Article I Name

Section 1.1 Name. The name of this corporation shall be GNEISS GIRLS, INC.

Article II Principal Office and Mailing Address
