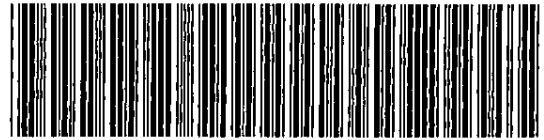

ARTICLE I


ARTICLE XI
