## ARTICLES OF INCORPORATION

## **ARTICLE I**

The name of the corporation is BROOKSIDE ANTIQUES AND FURNISHINGS CORP., and its mailing address and principal place of business is 5801 Congress Avenue, Boca Raton, Florida 33487.

## **ARTICLE II**

The corporation shall have perpetual existence.

#### **ARTICLE III**

## ARTICLE IX


The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.
