This corporation is authorized to issue 10,000 shares of common stock having a par value of \$.01 per share.

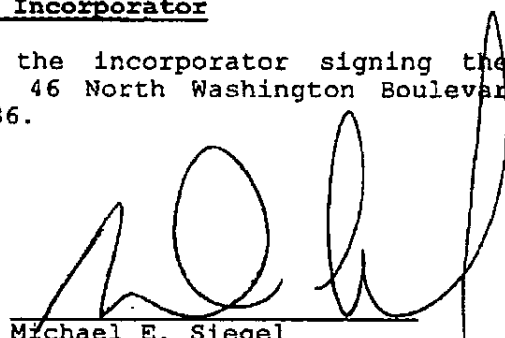

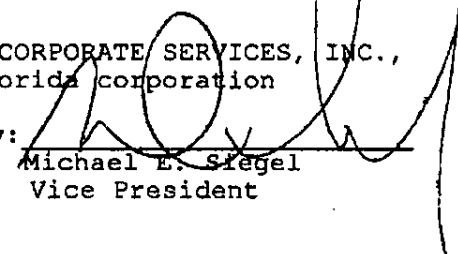
