# ARTICLES OF INCORPORATION

These Articles of Incorporation are adopted for the purpose of forming a corporation under the law of the State of Florida, to be filed with the Florida Department of State, as follows:

#### ARTICLE ONE: NAME

The name of the corporation is Reality Title Company and the address of its principal office is 3908 26th St W, Bradenton, FL 34205, until and unless such address is subsequently changed by the corporation.

#### ARTICLE TWO: COMMENCEMENT AND DURATION

The corporation shall commence its corporate existence as of 1 January 2009 and it shall exist perpetually thereafter until dissolved according to law.

#### ARTICLE THREE: PURPOSE

The corporation is organized for the purpose of transacting any and all business permitted corporations under Florida law.

#### ARTICLE FOUR: CAPITALIZATION

The corporation shall have the authority to issue one-hundred shares of common stock with a parvalue of one penny per share.
