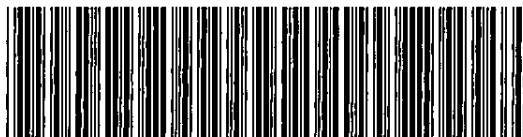

ARTICLES OF INCORPORATION

OF

ANTIFREEZE RECYCLERS, INC.

THE UNDERSIGNED incorporator, Harold T. Moore, an individual authorized to contract, hereby presents these Articles of Incorporation for the purpose of forming a corporation for profit under the provisions of Section 607, Florida Statutes.

ARTICLE I

NAME AND PRINCIPAL OFFICE OF CORPORATION

The name of the corporation is ANTIFREEZE RECYCLERS, INC. and its principal office and mailing address is located at 2747 Honeywood Drive, Pensacola, Florida 32514.

ARTICLE II

PURPOSES

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.

CAPITAL STOCK

The restrictions contained in this Article XII may be modified by a separate written agreement between the

corporation and the shareholder receiving shares in the initial issuance of stock of the corporation.
