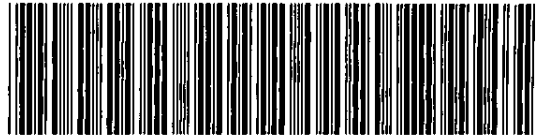

ARTICLE IV




