
ARTICLE VIII – INDEMNIFICATION



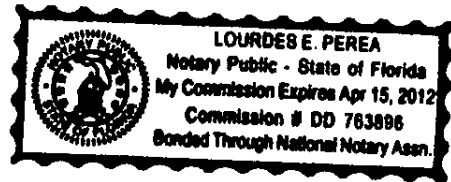


