ARTICLES OF INCORPORATION
OF

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I : NAME

ARTICLE II: NATURE OF BUSINESS

This corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

Other purposes include, but not limited to the following;

- A. Inform readers of the current state of political affairs from the perspectives of American citizens of all races, political parties, and religions.
- B. Poll readers on selected topics/opinions of controversy.
- C. Analyze the impact of current events on the national economy, small businesses, major corporations, employment, and international trading.
- D. Provide general overviews of the top ten newly released box office hits including; characters, plots, director biographies, and weekly gross estimates Report the top selling movies that are available on DVD.
- E. Allow readers to search for movie theatres within specified zip codes.
- F. Select an actor to feature weekly for outstanding performance, support, or first debut.
- G. Report television program ratings according to rank, program name, network, and number of viewers.
- H. Review Television programs according to actors, plot, and genre.
- I. Show television program times, channels, and networks.
- J. Publish the top ten music releases according to the Billboard entertainment charts.

- K. · Suggest healthy relationship-building and intimacy practices for couples of various arrangements.
- L. · Offer innovative ways to combat stress, and incorporate beneficial dietary routines.
- M. Feature new and popular artists through interviews and biographies.
- N. · Index common diseases and ailments that affect all people of all age groups and both sexes.
- O. Influence readers to incorporate mental exercises, meditation, and yoga techniques into daily routine.
- P. Produce informative health articles on women, men, children, and senior citizens.
- Q. Publicize innovative and healthy techniques for weight loss including diet alteration and physical fitness.
- R. Allow readers to respond to written articles through blogs, message boards, and emails.
- S. To purchase, lease, exchange, hire or otherwise acquire lands or any interest therein, wherever situated; to erect, construct, rebuild, enlarge, alter, improve, maintain, manage and operate any lands owned or leased by the corporation, buildings or other works owned, leased, managed or controlled by the corporation; to engage generally in the real estate business, as principal, agent, broker or otherwise, and generally to buy sell, lease, mortgage, exchange, manage, operate and deal in lands or interest in lands, houses, structures, buildings or other works; and to purchase, acquire, hold exchange, pledge, hypothecate, sell, deal in, deal with, and dispose of tax liens transfers of tax liens, and any other interests in real estate.
- T. To purchase, lease, exchange, hire or otherwise acquire lands or any interest therein, wherever situated; to erect, construct, rebuild, enlarge, alter, improve, maintain, manage and operate any lands owned or leased by the corporation.
- U. To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness and execute such mortgages, transfers of corporate property or other instruments to secure the payment of corporate indebtedness as required.
- V. To purchase the corporate assets of any other corporation and engage in the same or other character of business.
- W. To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares for the capital stock of, or any bonds, securities, or other evidences of the indebtedness created by any other corporation of the State of Florida or any other state or government, and while owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.
- X. To exercise all powers convenient, incident to, or necessary in the proper conduct of its business, which are granted to corporations for profit under the laws of the State of Florida, either by the terms of this charter or by virtue of the laws of the State of Florida.

ARTICLE III: CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock having a par value of \$ 1.00 per share; all shares shall be paid in full money of the United States of America in property, labor or services, the just value thereof shall be fixed by the Board of the Directors of the corporation in the manner provided for by the laws of the State of Florida.

ARTICLE IV: TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE V: AMENDMENTS

These Articles of Incorporation may be amended **ONLY** by Crystal Finlay or her designee.

ARTICLE VII: CONFLICT OF INTEREST




