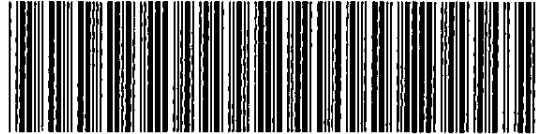

ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is XA Enterprises, Inc. Its principal office address and business mailing address is 6713 N.W. 84th Avenue, Miami, Florida 33166.

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

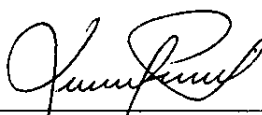
