ARTICLE 1

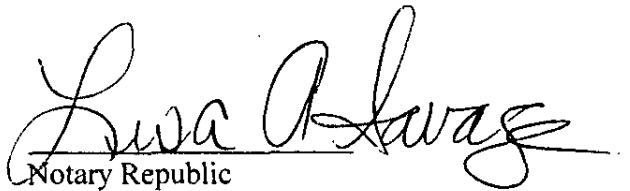

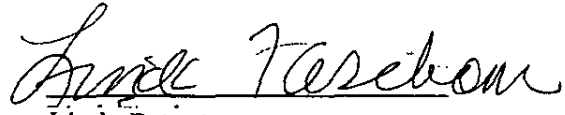
