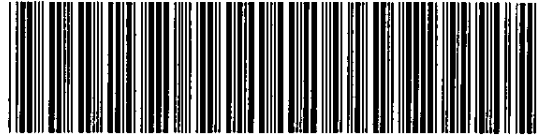

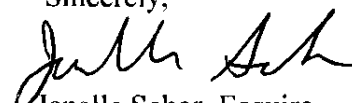
Dear Ms. Gibson:

As discussed in our conversation on December 16, 2008 and subsequent telephone calls, I am the victim of identity theft and fraud. (Davie, Florida Police Case No. 08-072812) (Pembroke Pines, Florida Police Case No. 2008-0999660). The person or people who have incorporated the companies of JAI Monds Jewelers, Inc. (Document Number P08000105185) and Mr. J. Bouncers, Inc. (Document Number P08000097639) have fraudulently used my identity and information to file articles of incorporation with the State of Florida, Division of Corporations. I am listed as the President and Registered Agent of these "companies." However, I did not authorize the filing of any articles of incorporation nor did I consent to being the President and Registered Agent. Further, I am now aware that someone is using these companies to commit check fraud. (Aventura, Florida Police Case. No. 08-007390). **Please dissolve these corporations immediately and remove me as the President and Registered Agent as they are fraudulent and illegal companies.**

Any companies formed in my name are fraudulent and unauthorized. In the future, if someone tries to start a company in my name and/or I am listed as the Registered Agent or an officer, please note that these are fraudulent companies and I should be notified immediately as should the police. **Please be advised that I am working with the law enforcement agencies named above and request that you provide me with any information that can assist in our investigation as we intend to prosecute the individuals responsible for this to the fullest extent of the law.**
