ARTICLES OF INCORPORATION

OF

Fun In the Sun, Inc. Vacation Rentals

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: Fun In the Sun, Inc. Vacation Rentals

Article 2. Address of principal office. The address of the principle office of the corporation is 3700 South Atlantic Avenue, New Smyrna Beach, FL 32169 and the mailing address of the corporation is 3700 South Atlantic Avenue, New Smyrna Beach, FL 32169.
