**ARTICLES OF INCORPORATION OF
DAVID J. DRIAPSA LANDSCAPE ARCHITECT CHARTERED**

The undersigned, acting as sole incorporator of a professional corporation to be formed under the Florida Professional Service Corporation and Limited Liability Company Act, hereby adopts the following Articles of Incorporation:

Article 1.
Name and Address

The name of the Corporation is David J. Driapsa Landscape Architect, Chartered. The principal office and mailing address of the Corporation is 725 103rd Avenue North, Naples, Florida 34108.

Article 2.
Duration

The duration of the Corporation is perpetual.

Article 3.
Purpose

The general purposes for which the Corporation is organized are the following:

A. To provide landscape architectural services as defined under Florida Statutes Chapter 481 and to engage in and transact any lawful business in connection with that purpose.

B. To do such other things as are incidental to the purpose of the Corporation or necessary or desirable in order to accomplish them and the Corporation shall have the specific powers and rights granted to and conferred on a corporation by the Professional Corporation and Limited Liability Company Act.

Article 4.
Shares

The aggregate number of shares which the Corporation is authorized to issue is One Thousand (1,000) shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

Article 8.
Amendment

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and any right conferred upon the Shareholders is subject to this reservation.

Article 9.
Restrictions

No one other than an individual who is duly licensed or legally authorized to render landscape architectural services in the State of Florida may own stock in this Corporation. No shareholder of this Corporation shall enter into a voting trust agreement or any other type agreement vesting another person with the authority to exercise the voting power of any or all of his or her stock. Any Shareholder who becomes legally disqualified to render licensed landscape architectural services shall sever all employment with and financial interest in the Corporation.

ARTICLES OF INCORPORATION

No shareholder of the Corporation may sell or transfer his or her stock in this Corporation, except to another individual who is eligible to be a Shareholder of the Corporation.

Article 10.
Indemnification


The Corporation shall indemnify each Officer and Director, including former Officers and Directors, to the full extent permitted by law, including but not limited to Florida Statutes Section 607.0850.
