ARTICLES OF INCORPORATION

FOR

CONCERTS INTERNATIONAL AGENCY, INC

ARTICLE I

The name of the corporation is: CONCERTS INTERNATIONAL AGENCY, INC. The mailing address of the corporation is: 7710-20 N.E. 56th Way, Suite 200, Pompano Beach, FL 33073.

ARTICLE II

The duration of the corporation shall be perpetual. The date and time of the commencement of the corporate existence of the corporation shall be upon filing these Articles of Incorporation with the Secretary of State of Florida.


