Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned ORID & Corporation adopts the following Articles of Amendment to its Articles of Incorporation, pursuant to a consent meeting of all of the shareholders and the members of the Board of Directors held on September 21, 2009:
