The undersigned incorporator does hereby make, subscribe, file and acknowledge these Articles of Incorporation for the purpose of organizing a corporation under the Florida Business Corporation Act and the Florida Professional Service Corporation Act for the purpose of engaging in the practice of medicine.

ARTICLE I

NAME OF CORPORATION

The name of this Corporation shall be Robert E. Given, Jr., P.A. (hereinafter, the "Corporation")

ARTICLE II

PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III

PURPOSE

The purpose for which the Corporation is organized is to provide real estate services and to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

In the event of any liquidation, dissolution or winding-up of the Corporation, whether voluntary of involuntary, the holders of Common Stock are entitled to share ratably in the net assets, if any, remaining after payment in full of all debts and habilities of the Corporation and after the holders of any outstanding class or series of capital stock ranking senior to Common Stock shall have been paid in full the amounts to which such holders shall be

entitled, or an amount sufficient to pay the aggregate amount to which such holders are entitled shall have been set aside for the benefit of the holders of such senior capital stock.
