The undersigned incorporator does hereby make, subscribe, file and acknowledge these Articles of Incorporation for the purpose of organizing a corporation under the Florida Business Corporation Act and the Florida Professional Service Corporation Act for the purpose of engaging in the practice of medicine.

ARTICLE I**NAME OF CORPORATION**

The name of this Corporation shall be Robert E. Given, Jr., P.A. (hereinafter, the "Corporation")

ARTICLE II**PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal office and mailing address of this Corporation is 151 Marietta Drive, Fort Lauderdale, Florida 33316

ARTICLE III**PURPOSE**

The purpose for which the Corporation is organized is to provide real estate services and to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

In the event of any liquidation, dissolution or winding-up of the Corporation, whether voluntary or involuntary, the holders of Common Stock are entitled to share ratably in the net assets, if any, remaining after payment in full of all debts and liabilities of the Corporation and after the holders of any outstanding class or series of capital stock ranking senior to Common Stock shall have been paid in full the amounts to which such holders shall be

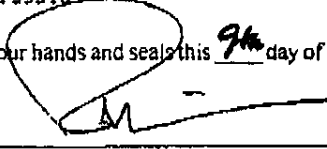

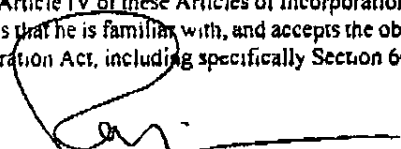
