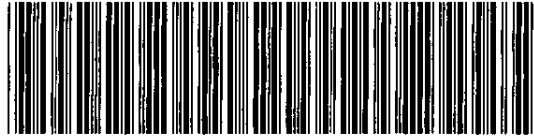

THE UNDERSIGNED, incorporator, for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ONE: The name of the Corporation is:  
ALDO INTERNATIONAL SALES, INC.

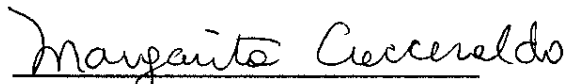
TWO: The principal place of business and mailing address of this Corporation shall be: 12765 SW 34 Place, Davie, Florida 33330
