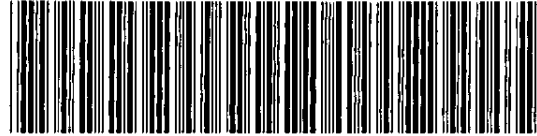

ARTICLE I: NAME

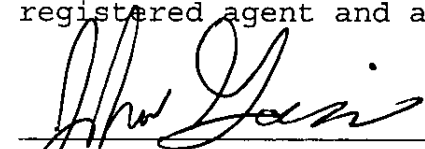

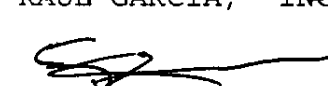
