CERTIFICATE OF INCORPORATION OF R G C SECURITIES INC.

on land to have the second of For the purpose of forming a corporation for profit under the general incorporation Laws of the State of Florida, it is respectfully requested of the Secretary of State the applications of the Secretary of Of such incorporation under the following Articles.

ARTICLE I

The name of this corporation shall be RGC Securities Inc. and it's principal place of business shall be at 2340 Oleander Drive, Miramar, FL 33023 with the right to change and move said principal place of business and establish such other offices and place of business within or without the State of Florida, as the Board of Directors may from time to time deem proper.

ARTICLE II

The general purpose and nature of the business of this corporation is to engage in any Activity or business with any or all powers for any or all purposes determined convenient or necessary by the Board of Directors as permitted under the laws of the United States and the State of Florida except as may be restricted under these Articles and its By-laws.
